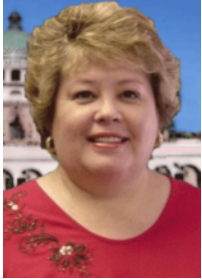

## ***County Recorder to Speak on Election Results***



A Tucson native and graduate of Salpointe Catholic High School, F. Ann Rodriguez was the first ever Hispanic female to be elected to a countywide office in Pima County. In November 2016, Ann was re-elected to her seventh term as Recorder, and continues to be the single highest "vote-getter" of all Pima County elected officials.

Because of her outstanding efforts for increasing voter participation in the 2002 Elections, Ann received two separate Special Recognition Awards in February 2003, one from Governor Janet Napolitano and one from the Tucson Chapter of the League of Women Voters. In 2004, Ann received the Arizona Democratic Party's second place "Democrat of the Year" award for her work in 2003. Also in 2004, Ann was inducted into the Arizona Democratic Party Hall of Fame. In 2012, Ann was recognized by The League of United Latino American Citizens (LULAC) with their Silver Award. She was also recognized for her role in the voting process in Pima County by the NAACP in 2012. Most recently, Ann received the Steve Emerine Election Integrity Award from the Democrats of Greater Tucson in September of 2016.

Ann has long been a community proponent and activist, and has been honored by a number of organizations for her dedication and service, including the Distinguished Service Award from the Hispanic fraternity Omega Delta Phi; the Outstanding Citizen's Support Award from the Gang Intelligence Team Enforcement Mission (GITEM); the Greater Tucson Leader Award; the Salpointe Alumni Service Award for Outstanding Community Service; and the nomination for the YWCA Women on the Move Award.

## ***Fund Drive a Success***

Our Community Food Bank Fund Drive in support of federal employees who were furloughed during the recent government shutdown proved successful. At last month's meeting we collected a total of \$370 in cash and checks, equaling \$3,300 worth of food purchasing power (\$9 for every one dollar donated) or 1,295 complete meals (7 meals for every two dollars donated). Our thanks to all of you who donated to the Fund Drive that evening and to all of you who chose to donate to the Fund Drive on-line at the Food Bank's website. In a phone interview with Food Bank representative Jeanette Sinotes, she stated that the Food Bank experienced a greater than average number of phone calls from concerned citizens wanting to know where, when, and how they could help the cause, recognizing the increased burden on the Food Bank's resources during that time. Ms. Sinotes added that, like us, other civic-minded organizations held food and/or fund drives to help feed the furloughed federal employees. We were not alone in our concern for their welfare, and we did make a difference.

Want to learn more about all of the good work the Food Bank is doing in our communities throughout Southern Arizona? Check out their website ([www.communityfoodbank.org/donate](http://www.communityfoodbank.org/donate)), and be inspired to keep on giving. For instance, according to "Our Challenge" section, "1.6 million Arizonans do not have reliable access to adequate food. Families often have to choose between food and housing, medical care, or education. 80% report they water down their food or purchase inexpensive, unhealthy food in order to cope." Closer to home, according to "Map the Meal Gap," more than 153,000 people (or 15.9%) of the population in Pima County are "Food Insecure." In other words, 3 in 20 people in our county cannot guarantee that they will be able meet their own nutritional needs and that of their family. According to "Our Commitment" section, in addition to feeding the hungry, the Community Food Bank maintains programs that provide nutrition education, offer garden workshops, and teach culinary skills.
