Dear Neighbor,

During these times of uncertainty, I am committed to working for you and your family and ensuring that your voice is heard.

So far, we have seen disorganization, confusion, and a breakdown of communication from the administration to state, local, and Tribal entities suffering from the COVID-19 pandemic. I have heard from too many Arizonans unable to apply for the unemployment benefits or small business loans they were promised.

Right now, I am working with my colleagues in the House of Representatives, as well as with state, local and Tribal leadership to ensure that the voices of Arizona families are not left out of our next legislative package.

New legislation to address the fallout from the coronavirus must guarantee additional funding for hospitals and health care professionals, increased access to personal protective equipment (PPE), a fix to the Paycheck Protection Program and an infusion of funds to the Small Business Administration.

The administration must amend its current competitive bidding structure between states and the Federal Emergency Management Agency and exercise its ability to produce additional supplies and kits to ensure that areas hit hardest by this virus, such as the Navajo Nation, do not have to fight for access to testing kits.

Testing, testing, testing. Until we have the capability to test all potentially infected people, we will not understand the full scope of this viral spread, hindering our ability to make an informed decision on when to reopen our nation.

As this public health crisis unfolds, I remain laser-focused on hearing from Arizona families on what is and isn't working, and what your federal government can do to better support you.

As always, if you need assistance with a federal agency or program, or have a question or a suggestion, reach out to any of my offices. We will get through this, together.

Call to Action: Vote-by-Mail and Saving U.S.P.S.

VOTE-BY-MAIL: The COVID-19 pandemic has made it crystal clear; vote-by-mail is vital to the safety of our election's process. The Arizona Legislative Republican majority has consistently blocked all vote-by-mail legislation. I'm contacting my legislators requesting all vote-by-mail options and urge you to do the same.

In the meantime, our Pima County Recorder, F. Ann Rodriguez is taking steps to increase the vote-by-mail numbers by sending out mailers to all voters not on the Permanent Early Voting List (PEVL). Her office has increased outreach efforts and has communicated with the Democratic Party leadership on outreach opportunities.

This is not a partisan issue, this is a safety issue for both voters and poll workers. 80% of voters choose to vote-by-mail, regardless of party affiliation. Requesting a ballot is easy. You can call the Recorder's Office at 520-724-4330, or go online at recorder.pima.gov (Pima County Recorder) or azsos.gov (AZ Secretary of State)

SAVING U.S.P.S.: Time is running out. The current administration wants to privatize our postal service and is using the pandemic as a tool to do just that. Our postal service delivers not only vote-by-mail ballots but lifesaving medications, pension checks, and, most recently, economic stimulus checks. If not funded, we will lose this 200-year-old vital service. Call your U.S. Senators and Representatives and let them know that you support our postal service.

Importance of Citizens Clean Elections Commission by Shea Stanfield, Candidate for Arizona Corporation Commission

Many of the voters who participate in the Arizona election process have heard the phrase "a Clean Elections Candidate." As I travel the State during my campaign I've noticed confusion around what it actually means to be a Clean Elections Candidate so I decided to do a short informational piece on the importance of Clean Elections in our election funding process.

The Citizens Clean Elections Act passed by voters in 1998 and is administered by a five member, non-partisan Commission. The Act established a system for voter education, clean funding for candidate campaigns and campaign finance enforcement. The purpose of the Act is to restore citizen participation and confidence in our political system, improve the integrity of Arizona State government and promote freedom of speech under the U.S. and Arizona Constitutions.

The programs Clean Elections offers are:

- Voter Education: The Commission has a voter education plan, developed annually in consultation with election officials and stakeholders. It focuses on educating voters about the logistics of voting as well as voting informed.
- Public Funding: The Commission provides an optional public financing program to qualified statewide and legislative candidates. They must meet certain requirements, among them collecting a certain number of \$5 qualifying contributions and agreeing not to accept contributions from PACs and corporations.
- Campaign Finance Enforcement: The Commission enforces the Clean Elections Act, including the public financing program, and has the authority to assess civil penalties on both participating and non-participating candidates.
- Clean Elections Fund: The voters of Arizona established the Citizens Clean Elections Fund, which is comprised from:
 - 1) 10% surcharge on all civil penalties and criminal fines,
 - 2) civil penalties paid by candidates, and
 - 3) \$5 qualifying contributions collected from participating candidates.

I am running for the Arizona Corporation Commission as a Clean Elections Candidate. For me to qualify for State funds to run my campaign I need 1800 individuals to donate a qualifying \$5. I don't need to tell you how important it is to keep monopoly corporation money out of a race to elect individuals that regulate them. Voting Rights Republican Style

The recent election in Wisconsin showed us the barriers and risks to life Republicans support to prevent voting by mail.

LD11 state Senator Vince Leach and Representative Mark Finchem both believe that voting by mail ensures voter fraud.

The coronavirus is creating a conflict between “shelter-in-place” and the imperative to vote in our democracy. We are being warned that virus protective measures might be required as late as August and November when we are scheduled to hold primary and national elections.

We are very fortunate to live in Arizona during this pandemic. We already have the systems and equipment in place to allow voters to social distance while voting. Called the Permanent Early Voting List (PEVL), it allows individual voters to receive ballots in the mail and have their votes counted by returning the marked ballots to the county recorder either by mail or in person at designated drop off locations. Signing up is easy through your recorder’s website or at <https://servicearizona.com/>. This will ensure voter health and safety and minimize the number of people who must risk their health and safety by staffing polling places.

Health protection is now added to the many reasons for receiving an early ballot by mail: work complications; lack of a polling place nearby; long lines at polling places; illness; lack of transportation; bad weather; and ballot complexity requiring more time for thought. For those who worry that this method is less secure than voting at polling places be assured the recorders have the equipment to verify signatures and will contact voters should there be a mismatch to assure authenticity. In 2016 75% of the 2.7 million Arizona voters used PEVL. There were only 7 cases of voter fraud and most were snowbirds voting in two states. Our system is safe and secure.

Besides signing up for PEVL, please also contact Governor Ducey and legislators to request they protect us and poll volunteers by having ballots mailed to all voters for the next two elections. Thank you.
